

INTERNET BEDROOM TERMS OF USE

Welcome! Please take a moment to scroll down and read these Terms of Use.

Discz Music, Inc. ("Internet Bedroom," "we," "us," or "our") welcomes you. We invite you to access and use the Internet Bedroom web application and related services (collectively, the "Service"), which are made available to you at <https://internetbedroom.com>. These Terms of Use state the terms and conditions under which you can use the Service. Throughout these Terms, the terms "you" and "your" refer to any visitor to or user of the Service.

Please read these Terms of Use carefully before you start using the Service. BY CREATING A BEDROOM, CLAIMING A HANDLE, ENTERING YOUR INFORMATION, OR OTHERWISE USING THE SERVICE YOU: (A) ACKNOWLEDGE THAT YOU HAVE READ, UNDERSTOOD, AND AGREE TO BE LEGALLY BOUND BY THESE TERMS OF USE AND (B) REPRESENT THAT YOU ARE 13 YEARS OF AGE OR OLDER. If you do not agree to any of these terms, then please do not use the Service. These Terms of Use may be updated by us from time to time with or without notice to you.

I. USE OF THE SERVICE

Welcome to Internet Bedroom! The Service provides a platform that allows you to: (i) generate a personal "bedroom" — a visual, personalized web page — based on music data from your connected music streaming account(s); (ii) customize your bedroom, including its theme, title, bio, posters, decor, and other elements; (iii) claim a personal handle so your bedroom is available at myinternetbedroom.com/{your-handle}; (iv) earn and use Coins (defined below) to unlock themes, decor, and other Virtual Items; (v) upload your own images or stickers to display in your bedroom; (vi) allow visitors to view your bedroom, sign your guestbook, and leave stamps and emoji; (vii) link your bedroom to your friends' bedrooms as part of your "neighborhood"; and (viii) use other functionalities provided on the Service. The Service, its functionality, and features may be changed or updated by us from time to time in our sole discretion.

PLEASE NOTE: YOUR BEDROOM IS PUBLIC. Your bedroom — including your handle, bedroom title, bio, decor, custom uploads, guestbook entries, visitor count, and other room contents — is publicly viewable by anyone with the link to your bedroom. Do not include in your bedroom any information you do not want to be public. We disclaim all liability related to third-party use of any content you make available through your bedroom.

II. AGE RESTRICTIONS

By using and/or registering and/or providing any information on the App, you certify that you are at least thirteen (13) years of age. If you are under 13 years of age you must refrain from downloading, installing or using the App, or delete the App from your mobile device. In the event that we learn we have collected personal information from a child under the age of 13, we will delete that information as quickly as possible. If you believe we may have information from a child under 13, please contact us at support@housewarming.me.

If you are 13 or older, but under the age of majority in your jurisdiction (each a “Minor”), you should review this Agreement with your parent or guardian to make sure that you and your parent or guardian understand it and agree to the terms.

NOTICE TO PARENTS AND GUARDIANS OF MINORS: You are responsible for monitoring and supervising your child’s use of any services offered on the App. If your child is using any of our services without your express consent, please contact us immediately so that we can disable his or her access. III. MUSIC SERVICE CONNECTIONS

To generate and refresh your bedroom, the Service allows you to connect third-party music streaming accounts, including Spotify and Apple Music (each a "Music Service"). By connecting a Music Service, you authorize us to access certain information from that Music Service, such as your listening history, top artists and tracks, and related music data, as permitted by that Music Service and your settings there.

Your use of any Music Service is governed by that Music Service's own terms of use and privacy policy, and you are responsible for complying with them. We encourage you to review those terms and policies. We are not affiliated with, endorsed by, or sponsored by Spotify, Apple, or any other Music Service, and we disclaim all liability related to your use of any Music Service. If a Music Service changes or discontinues access to its data, some features of the Service (including automatic room generation and daily updates) may not function properly.

Your bedroom's contents, including songs and decor, may update automatically based on your listening activity on connected Music Services.

IV. AUTOMATED AND AI-ASSISTED GENERATION

Portions of your bedroom — including its initial layout, theme, decor, and daily changes — are generated automatically, and may be generated or curated using artificial intelligence or other automated systems, based on your music data and information you provide. By using the Service, you acknowledge that: (i) automatically generated content may not always be accurate, appropriate, or to your taste; (ii) you are responsible for reviewing your bedroom and its contents before sharing it; and (iii) we may use third-party service providers to deliver these features, and such providers may change from time to time.

V. CHANGES TO THE TERMS OF USE

From time to time and in our sole discretion, we will change or make additions to these Terms of Use, in which case we will post the revised Terms of Use on the Service, and the revised Terms of Use will be effective immediately upon posting. You are responsible for reviewing the most current version of the Terms of Use before using the Service to ensure that you agree to any revisions to the Terms of Use. If at any time you do not agree to the revisions, you should immediately cease all use of and access to the Service. By continuing to use the Service after we post any such changes, you accept the Terms of Use, as modified.

VI. YOUR ACCOUNT AND HANDLE

If you want to access certain features offered by us — including claiming your bedroom, saving changes, and receiving daily updates and decor — you may be required to create an account on the Service ("Account") by providing certain information such as your email address and a handle (username). You must provide complete and accurate registration information and notify us if your information changes. In creating a handle, bedroom title, or bio, you may not use someone else's name or a name, handle, or image that violates our community guidelines, infringes anyone's rights, or is deceptive, vulgar, or offensive.

Handles are made available on a first-come, first-served basis, but we do not guarantee the availability of any handle, and we reserve the right to reclaim, reassign, or disable any handle at any time in our sole discretion, including handles that are inactive, violate these Terms, or infringe the rights of others (for example, trademark rights).

If you create an Account, you must treat information related to your Account as confidential, and you must not disclose it to any other person or entity. You are responsible for all activity performed and transactions entered into on or through your Account, and you agree that we may treat any activity performed or transaction entered into on or through your Account as authorized by you. You agree to notify us immediately of any unauthorized access to or use of your Account or any other breach of security.

We have the right to disable any handle, username, password, or other identifier, whether chosen by you or provided by us, at any time in our sole discretion for any or no reason, including if, in our opinion, you have violated any provision of these Terms of Use.

VII. COMMUNITY GUIDELINES

Internet Bedroom is all about expressing yourself. To make sure we keep everyone safe, and have a great time, we have a few ground rules to play by. These rules apply to everything you post or display through the Service, including your bedroom, handle, title, bio, custom uploads, guestbook entries, and stamps.

Respect and Support other Members of the Internet Bedroom Community

- **Threats, Bullying and Harassment:** Don't threaten others with harm including bullying, stalking, trolling, harassment, intimidation, extortion and blackmail.
- **Discrimination and Hate Speech:** Don't discriminate, mock or promote hatred against individuals or groups or encourage others to do so on the basis of race, ethnicity, gender, sexual orientation, religion or nationality.
- **Suicide and Self Injury:** Don't post content that depicts, glorifies or encourages suicide or self-injury.
- **Sexual Content and Nudity:** Don't share explicit or pornographic sexual content.

- **Product Abuse:** Don't abuse the Service, products, features, or services.

Follow the Law

- **Intellectual Property Rights:** Upload only images, stickers, and other content that you've created or have the right to share.
- **Child Endangerment:** Don't endanger minors through manipulation, exploitation, sexualization or discussing child sexual exploitation material.
- **Terrorism and Violent Attacks:** Don't organize, promote or support violent extremism, terrorism, or any form of extremist ideologies.
- **Illegal Behavior:** Don't organize, promote or engage in any illegal activities or behavior that violates local, national or international laws.

You have no rights in or to the Internet Bedroom Content, and you will not use the Internet Bedroom Content except as permitted under this Agreement and the functionality of the Service. XIX. INDEMNIFICATION

You agree to defend, indemnify, and hold harmless the Internet Bedroom Parties from and against any and all damages, liabilities, losses, costs, and expenses, including reasonable attorney's fees (collectively, "Losses") incurred by any Internet Bedroom Party in connection with a third-party claim, action, or proceeding (each, a "Claim") arising from: (i) your use of the Service, including any automatically generated or AI features; (ii) your breach of this Agreement; (iii) any misuse of the Internet Bedroom Content and/or the Service; (iv) your violation of any third-party right, including without limitation any copyright, trademark, property, or privacy right; and (v) any User Contribution submitted by you or any other content you post or otherwise contribute, including but not limited to any User Contribution that is submitted by you without the required consents and permissions.

XX. TERMINATION OF THE AGREEMENT

XXI. BINDING ARBITRATION

In the event of a dispute arising under or relating to this Agreement or the Service or any other products or services provided by us (each, a "Dispute"), such dispute will be finally and exclusively resolved by binding arbitration governed by the Federal Arbitration Act ("FAA"). All applicable JAMS' rules and procedures are available at the JAMS website <http://www.jamsadr.com>. Each party will be responsible for paying any JAMS filing, administrative and arbitrator fees in accordance with JAMS rules. Judgment on the arbitrator's award may be entered in any court having jurisdiction. This clause shall not preclude parties from seeking provisional remedies in aid of arbitration from a court of appropriate jurisdiction. The arbitration may be conducted in person, through the submission of documents, by phone, or online. If conducted in person, the arbitration shall take place in the United States county where you reside. The parties may litigate in court to compel arbitration, to stay a proceeding pending arbitration, or to confirm, modify, vacate or enter judgment on

the award entered by the arbitrator. The parties shall cooperate in good faith in the voluntary and informal exchange of all non-privileged documents and other information (including electronically stored information) relevant to the Dispute immediately after commencement of the arbitration. Nothing in this Agreement will prevent Internet Bedroom from seeking injunctive relief in any court of competent jurisdiction as necessary to protect Internet Bedroom's proprietary interests.

XXII. CLASS ACTION WAIVER

You agree that any arbitration or proceeding shall be limited to the Dispute between us and you individually. To the full extent permitted by law, (i) no arbitration or proceeding shall be joined with any other; (ii) there is no right or authority for any Dispute to be arbitrated or resolved on a class action-basis or to utilize class action procedures; and (iii) there is no right or authority for any Dispute to be brought in a purported representative capacity on behalf of the general public or any other persons. YOU AGREE THAT YOU MAY BRING CLAIMS AGAINST US ONLY IN YOUR INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING.

XXIII. EQUITABLE RELIEF

You acknowledge and agree that in the event of a breach or threatened violation of our intellectual property rights and confidential and proprietary information by you, we will suffer irreparable harm and will therefore be entitled to injunctive relief to enforce this Agreement. We may, without waiving any other remedies under this Agreement, seek from any court having jurisdiction any interim, equitable, provisional, or injunctive relief that is necessary to protect our rights and property pending the outcome of the arbitration referenced above. You hereby irrevocably and unconditionally consent to the personal and subject matter jurisdiction of the federal and state courts in the State of New York for purposes of any such action by us.

XXIV. CONTROLLING LAW; EXCLUSIVE FORUM

The Agreement and any action related thereto will be governed by the laws of the State of New York without regard to its conflict of laws provisions. The Parties hereby consent and agree to the exclusive jurisdiction of the state and federal courts located in the State of New York for all suits, actions, or proceedings directly or indirectly arising out of or relating to this Agreement, and waive any and all objections to such courts, including but not limited to, objections based on improper venue or inconvenient forum, and each party hereby irrevocably submits to the exclusive jurisdiction of such courts in any suits, actions, or proceedings arising out of or relating to this Agreement.

XXV. MISCELLANEOUS

If the Agreement is terminated in accordance with the termination provision in Section XXI above, such termination shall not affect the validity of the following provisions of this Agreement, which shall remain in full force and effect: "Intellectual Property," "Coins and Virtual Items," "Communications with Us,"

"Limitation of Liability; Disclaimer of Warranties," "Indemnification," "Termination of the Agreement," "Controlling Law; Exclusive Forum," and "Miscellaneous."

Our failure to act on or enforce any provision of the Agreement shall not be construed as a waiver of that provision or any other provision in this Agreement. No waiver shall be effective against us unless made in writing, and no such waiver shall be construed as a waiver in any other or subsequent instance. Except as expressly agreed by us and you in writing, this Agreement constitutes the entire Agreement between you and us with respect to the subject matter, and supersedes all previous or contemporaneous agreements, whether written or oral, between the parties with respect to the subject matter. The section headings are provided merely for convenience and shall not be given any legal import. This Agreement will inure to the benefit of our successors, assigns, licensees, and sublicensees. You may not assign these Terms, in whole or in part, nor transfer or sublicense your rights under these Terms, to any third party.
